We specialize in digitalizing corporate and public procurement in Central Europe. We use our internet applications under the PROEBIZ brand for our activities. The applications are localized into many languages. We are and want to be known in the market for the quality of our tools and services, friendship, a high level of proactivity and creativity.

Our goal is to cover the procurement process with functional and data-connected tools. The products of the PROEBIZ portfolio are attractive to customers because they enable them to add value to procurement processes quickly and at no significant cost.

## **PROEBIZ brand applications:**

PROEBIZ TENDERBOX - used to implement electronic tenders, i.e. eAuctions, Demands, Bidding, etc. PROEBIZ JOSEPHINE - used for electronic submission of bids in the field of public administration PROEBIZ MARQUET - internal electronic shop – e-shop PROEBIZ WENDY - used for the computerization of not only purchase requests PROEBIZ BASE – a shared catalog of qualified suppliers.

Since 2004 we have been organizing procurement conference – now the eBF festival. It is one of the most significant events in Central Europe, focusing on the digitalization of corporate and public procurement. Its programme usually takes place over three days in several halls or stages simultaneously.

In 2018, a consulting team of more than fifty corporate and public procurement specialists was formed during the preparation for the eBF conference - the PROCUREMENT BOARD. It now serves the company in development and training activities.

In 2021, we created a semester-long certificate course, The Digital Procurement Team. Its content was developed in collaboration with the PROCUREMENT BOARD team. The Dean's Office of the Faculty of Economics of the University of Mining and Metallurgy - Technical University sponsored the certification. This course is repeated every year.

In 2023, we have expanded our training offer with an additional semester course dedicated to the public sector. This is the Digital Public Procurement Team. Like the course for companies, it is held with the possibility of online but also offline participation in Ostrava.

In response to the covid situation, the streaming procurement television eProcurement TV was created, which broadcasts 8 hours a day on weekdays via the Internet. These are mainly programmes with a purchasing theme. The broadcasts are available for free for one month and then all videos are available in an online film library for an annual fee. The programmes are broadcast in Czech, Slovak, Polish and English.

A new version of the PROEBIZ TENDERBOX tendering tool was launched in 2025. Its designation is version 4.AI. It is a revolutionary new solution for the implementation of tenders using AI elements. We refer to this tool as a new generation sw.
